A JOINT LABORATORY WITH THE UNIVERSITY OF SORBONNE AND SBM COMPANY FOR NATURAL PEST CONTROL SOLUTIONS.

Paris, April 12, 2018 – SBM Company and the University of Sorbonne combine their expertise and inaugurate NatInControl, a research project established to identify and develop new biocontrol solutions efficient for plant protection against pests.

Because the future of agriculture and gardening is evolving and will require solutions that are more environmentally-friendly, biocontrol products are a major stake to respond to the societal, political and environmental challenges of tomorrow's world.

The shared vision of SBM Company and the University of Sorbonne is to create an expertise center specialized in biocontrol solutions to fight against invasive pests.

The research project NatlnControl consists of selecting active substances based on microorganisms and plant extracts, offering the best plant protection against pests. As a first step, the scientific works will improve the knowledge on biology-ecology of the target species and to target biocontrol solutions in controlled conditions. Leading solutions will then be tested via effectiveness tests on fields, then their mode of operation and their impact on the environment will be studied.

"Our partnership with SBM Company is part of the innovation and development foundation of the University of Sorbonne. This close link with a professional of the sector will enhance our applied research contributing to the launch of new biocontrol products" says Corinne Aubert, Dean of the Faculty of Applied Science and Engineering of University of Sorbonne.
